SheyPhoksundo Rural Municipality, Office of The Rural Municipal Executive has allocated funds from Government of Nepal, GoN towards the cost of "Ward no 1 Health Post Building Construction Works" and intends to apply part of the funds to cover eligible payments under the Contract for the procurement of Ward no 1 Health Post Building Construction Works and Contract Identification number :SPRM/NCB/DOP/WORKS/2077/078-01. Bidding is open to all eligible as per Section V of bidding document..

2. SheyPhoksundo Rural Municipality invites electronic bids from eligible bidders for the Ward no 1 Health Post Bullding Construction Works under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs 30,000,000
- Minimum Work experience of similar size and nature: one single project and value of NRs 15,000,000 excluding VAT of the contract amount.
- Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
- 4.
